108

109 The Fraunhofer FDK AAC Codec Library for Android ("FDK AAC Codec") is software

Preamble

178
179 The licenses for most software are designed to take away your freedom to share

180
181 This license, the Lesser General Public License, applies to some specially
designated software packages--typically libraries--of the Free Software
Foundation and other authors who decide to use it. You can use it too, but we
suggest you first think carefully about whether this license or the ordinary
General Public License is the better strategy to use in any particular case,
based on the explanations below.

182
183 When we speak of free software, we are referring to freedom of use, not price.

184
